

Key information about the home

There are variations of shared ownership models which have different features. The model of shared ownership may vary depending on:

- what rules were in place at the time the home was funded or planning permission granted
- where the home is located
- whether the home is for a specific group of people

The table below highlights the key features of common shared ownership schemes. The information in this document is for the **new model shared ownership**.



When you are looking for shared ownership homes, you should always check the Key Information Document to see which model covers that specific home.

When you buy a home through shared ownership, you enter into a shared ownership lease. The lease is a legal agreement between you (the 'leaseholder') and the landlord. It sets out the rights and responsibilities of both parties.

Before committing to buy a shared ownership property, you should take independent legal and financial advice.

This key information document is to help you decide if shared ownership is right for you. You should read this document carefully so that you understand what you are buying, and then keep it safe for future reference. This document 'Key information about the home' is a summary and you should consider the information in 'Summary of costs' and 'Guide to shared ownership' before making a decision.





This does not form part of the lease. You should carefully consider the information and the accompanying lease and discuss any issues with your legal adviser before signing the lease.

Failure to pay your rent, service charge, or mortgage could mean your home is at risk of repossession.

The costs in this document are the costs as at the date issued. These will increase (typically on an annual basis) and you should take financial advice on whether this will be sustainable for you.

	The percentage share and rent amount will change depending on the amount you can afford. You'll receive a worked example after a financial assessment. Your annual rent is calculated as 2.75% of the remaining share of the full market value owned by the landlord.

Reservation fee	£500.00		
	You'll need to pay a reservation fee to secure your home. When you pay the fee, no one else will be able to reserve the home.		
	The reservation fee secures the home for 84 days, subject to practical completion of the property. the fee will be credited to your rent account on completion. If you cancel within the first 14 days from the date of the offer, we will pay back the reservation fee in full. After 14 days, we will pay back the reservation fee deducting any incurred costs.		
Eligibility	You can apply to buy the home if both of the following apply:		
	 your household income is £80,000 or less, and you cannot afford all of the deposit and mortgage payments to buy a home that meets your needs 		
	One of the following must also be true:		
	 you're a first-time buyer you used to own a home but cannot afford to buy one now 		
	 you're forming a new household - for example, after a relationship breakdown you're an existing shared owner, and you want to 		
	move		
	 you own a home and want to move but cannot afford to buy a new home for your needs 		
	If you own a home, you must have completed the sale of the home on or before the date you complete your shared ownership purchase.		
	As part of your application, your finances and credit history will be assessed to ensure that you can afford and sustain the rental and mortgage payments.

Rent Review	Your rent will be reviewed each year by a set formula using the Retail Prices Index (RPI) for the previous 12 months plus 0.5%
	For more information, see the Rent Review section in the 'Summary of Costs' document which includes an example of how rent could increase over a 5 year period. A worked example demonstrating how the rent is calculated at review is also set out in Appendix 2 of the lease.
Maximum share you can own	You can buy up to 100% of your home.
Transfer of freehold	At 100% ownership, the freehold will transfer to you.
Landlord	Plymouth Community Homes Plumer House Tailyour Road Plymouth PL6 5DH Under a shared ownership lease, you pay for a percentage share of the market value of a home. You enter into a lease agreement with the landlord, and agree to pay rent to the landlord on the remaining share.
Initial repair period	This home is not a new build and therefore this does not apply.

Landlord's first option to buy	When you give the landlord notice that you intend to sell your share in your home, the landlord has 4 weeks to find a buyer. (The landlord may offer to buy back your share, but only in exceptional circumstances and if they have funds available.) If they do not find a buyer within 4 weeks, you can sell your share yourself on the open market. For example, through an estate agent.

Subletting

You can rent out a room in the home at any time, but you must live there at the same time.

You cannot sublet (rent out) your entire home unless either:

- you own a 100% share
- you have your landlord's permission, which they will only give in exceptional circumstances

If you're a serving member of the armed forces, and you're required to serve away from the area where you live for a fixed period, you may sublet the entire home subject to the landlord's permission.
